
## 1. INTERNATIONAL TRADE IN HORSEMEAT

## TRADE IN MEAT AND BY-PRODUCTS

World consumption of horsemeat is mainly concentrated in some European countries, mainly Italy, Belgium, France, Russia, Switzerland, among others. In these countries it is considered a quality product and there are butcher shops specializing in horsemeat, offering commercial cuts similar to beef, sausages and processed products. Horse products are also found in supermarkets and restaurants. Outside of Europe, China and Japan also demand this type of meat. Total annual exports are 120,754 tones, equivalent to US\$ 434,425 million.

Horsemeat is considered to be of high nutritional value and low in fat, rich in minerals, iron and vitamins. It is also used for medicinal purposes in the production of immunosera, due to the blood volume and because they are good antibody producers from which homologous serums are obtained to enrich culture media and heterologous serums including anti-arachnid, antivenom, tetanus, botulinum and diphtheria antitoxin.

## 2. HORSEMEAT EXPORTS IN URUGUAY

## **MEAT AND BY-PRODUCTS**

Horsemeat production in Uruguay is a minor activity that stems from the different uses of these animals (work, competition, pleasure). There is no commercial breeding for meat production as in some other countries, especially in Europe.

Since 2000, national equine slaughtering has been around 40,000 heads per year. There are three authorized plants: Sarel S.A -located in the department of Canelones- which accounted for 46% of total exports of horsemeat and by-products in 2020, Agroindustrial del Este -located in the department of Treinta y Tres- with 36% of total exports for the same period, and Clay S.A -located in the department of Canelones- with 18% of it.

Total horsemeat exported in 2020 was US\$ 20 million, constituting the main source of foreign exchange for the sector. The main exportable product from the slaughter industry in the last three years was chilled boneless horsemeat, which accounted for 58% of total horsemeat exports

in 2020. On the other hand, forequarters made US\$ 4 million in 2020, followed by hindquarter cuts that reach US\$ 3 million for the same period.

In terms of export destinations, Belgium and Russia are the main destinations for Uruguayan horsemeat, accounting for 75% of the turnover.
